**AN ORDINANCE BY THE CITY COUNCIL OF THE CITY OF LAGO VISTA, TEXAS PROVIDING FOR AN ORDER CANVASSING THE RETURNS OF THE CITY OF LAGO VISTA'S MAY 9, 2015 GENERAL ELECTION FOR THE OFFICE OF COUNCIL MEMBER PLACE 2, COUNCIL MEMBER PLACE 4, AND COUNCIL MEMBER PLACE 6, ALL OFFICES OF WHICH ARE ELECTED ON AN AT LARGE BASIS.**

**THAT**, there came on to be considered the returns of an election held on the 9<sup>th</sup> day of May, 2015, for the purpose of electing the hereinafter named officials, and it appearing from said returns, duly and legally made, that there were cast at said election **2,797** valid and legal votes; that each of the candidates in said election received the following votes:
