A PERSON WHO OPERATES AN ALARM SYSTEM MUST:

1. Obtain an alarm permit from the Lago Vista Police Department Alarm Unit. A separate permit is required for each alarm site. Permits are **\$35.00 and are renewed every year for \$25.00**. Permits are not transferable and are non-refundable. A change of address or name requires the issuance of a new permit.
2. Maintain the premises of the alarm in a manner that ensures proper operation of the alarm system and minimizes false alarm calls.
3. Ensure that the alarm system does not automatically dial the **9 1 1 Emergency Communications System**. Also, the alarm should not sound more than **15 minutes** after being activated; and should automatically reset before transmitting another signal. The cumulative sounding of the audible alarm shall not exceed 30 minutes without manual reset.
4. Respond or cause a representative to respond within one hour when notified by the Police Department to provide access to the premises, provide security for the premises, or inactivate or repair a malfunctioning alarm system.
5. Not activate an alarm for any reason other than the occurrence of an event that the alarm system was intended to report. **A HOLD-UP, Panic, or Hostage device should only be activated in a life-threatening situation.** In addition, all users of the alarm should be properly educated in the use of the alarm system.

A person who violates any of the above requirements may be cited to court for the violation.

FEES:

A \$50.00 fee is charged for each false burglary alarm notification that is in excess of 5 (five) false alarms in a 12 month continuous period.

A PERM T CAN BE REVOKED FOR:

1. Any false statement made in the application process.
2. Any violation of the provisions of the Alarm Ordinance.
3. Non-payment of fees.

If a permit is revoked, it is classified as non-permitted and is placed in "NO RESPONSE" status until the violation is corrected and/or all fees are paid. If a permit has been revoked, the permit holder can not obtain a permit for another location.
